

LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

The text description for the above chart is as follows: The total revenue projected for Atascadero Unified School District is \$66,465,599.00, of which \$55,027,440.00 is Local Control Funding Formula (LCFF), \$6,786,687.00 is other state funds, \$2,733,521.00 is local funds, and \$1,917,951.00 is federal funds. Of the \$55,027,440.00 in LCFF Funds, \$4,622,164.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.



General Information

Students:

Atascadero Unified School District has an enrollment of approximately 4,300 students. Approximately 56% of our population is White, 30% are Hispanic, and 14% are other ethnicities including American Indian, Asian, African American, Filipino, and Two or More Races. Approximately 48% of the district population is low-income, 7.5% of our students are categorized as English Language Learners, students identified as Homeless is 4%, Foster Youth is 0.8%, and Students with Disabilities is 15.2%.

School Facilities:

Atascadero Unified School District is a TK-12 rural district comprising twelve schools. Geographically, three of the District's schools lie in the unincorporated areas of Santa Margarita, Carrisa Plains and Creston. All other school sites are located within Atascadero city limits. The District is served by seven TK-5 elementary schools, one 4-8 Fine Arts Academy, one middle school, one comprehensive high school, one continuation high school and one 9-12 alternative education school serving independent study students. Home-school and independent studies are also available to students in K-5 within San Benito Elementary School and 6-8 at the Fine Arts Academy. Improvements were made to every classroom through a \$117 million facilities bond passed by our community in 2010 and reauthorized in 2014.

Geographic Areas:

Our district serves one of the largest unified school district geographic areas in the state of California encompassing 1,213 square miles. The district stretches from the City of Atascadero to the Carissa Plains in eastern San Luis Obispo County. Although our student population is not considered ethnically diverse, the regions that comprise the unified school district draw from a wide range of socially and economically diverse citizens.

Schools Receiving Equity Multiplier funding:

Carrisa Plains Elementary is receiving Equity Multiplier funding for the 2025-2026 school year.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Successes:

Local ELA Assessments: Significant gains were observed in the district's local ELA assessments (FastBridge) across all student groups, particularly for Long-Term English Learners (+11.2%) and Foster Youth (+20%). The "All" students group also showed an increase of +5%.

California School Dashboard shows a continued decrease in Chronic Absenteeism, reducing by 3.8%.

College Career Indicator (CCI) - Overall Preparedness: A modest increase was seen in the overall percentage of graduates identified as prepared by the CCI (+3.4%). Similar positive trends, albeit smaller, are noted for Low-Income students (+0.6%) and Students with Disabilities (+2.4%). Homeless students also showed improvement (+5.3%). A positive trend is observed in the percentage of graduates meeting both A-G requirements and CTE Pathway Completion for all students (+3%), Low-Income students (+0.6%), and Students with Disabilities (+2%).

Improved Behavior Outcomes: California School Dashboards show a decrease in suspensions by 0.7%, though district-wide local data regarding suspensions demonstrate a negligible increase of 0.45% compared to last year. This positive change is attributed to both school-wide PBIS initiatives and additional counselors who provided targeted support for students with social-emotional needs.

These accomplishments demonstrate our commitment to preparing students for college and careers, while fostering a positive and supportive learning environment.

Each school within AUSD that had qualified for CSI or TSI has exited their qualifications for support by progressing out of the lowest indicators that qualified them through the 2023 California School Dashboard.

Challenges:

While we celebrate successes, we also acknowledge areas needing attention:

California School Dashboard ELA Average Distance from Standard: The average distance from the ELA standard worsened for all students (-7.5), Low-Income students (-5.1), Students with Disabilities (-4.7), English Learners (-10.5), and Long-Term English Learners.

California School Dashboard Math Average Distance from Standard: The average distance from the Math standard also worsened for all students (-3.7), Low-Income students (-4.4), Students with Disabilities (-4.5), English Learners (-5), and Long-Term English Learners again show a large gap in comparison to their peers.

As reported on the California School Dashboard, College Career Indicators (CCI) did show an increase, but are still lower than we feel they should be, with only 41.7% of students prepared according to the CCIs. Students who are homeless, Hispanic, low-income, or have a disability are demonstrating CCI preparedness at a much lower rate, only making it to the Very Low and Low levels.

Academic Counseling & Accountability: Counselors are primarily addressing social-emotional needs, with limited time for academic support and career planning for 34% of students. This need is echoed by student input and highlights a need for increased efforts and accountability in these crucial areas.

The 2023-2024 CA Dashboard showed an overall decrease in suspensions, with a slight increase for ELs and Homeless subgroups. Current data shows that 251 students violated Ed Code 48900, with only 179 of them being suspended (representing a 0.45% increase from the previous year). In reviewing the students who violated Ed Code 48900, 31% of those students have received alternatives to suspension but not suspended, 8% received alternatives to suspension and were still suspended, and 61% were suspended with no alternative given. Of the students suspended, 8% of those students received post suspension counseling.

Learning Recovery and Emergency Block Grant:

AUSD has unexpended LREBG funds for the 2025-26 school year. LREBG funded actions are found in Goal 1, Action 1.8

Utilizing the needs assessments within the process for LCAP, Differentiated Assistance (DA), and Compliance and Improvement Monitoring (CIM), evidence substantiated findings from the 2024 Dashboard related to student achievement. A review of all data and systems within LCAP, DA, and CIM demonstrate a discrepancy in each student group's achievement on local assessments in comparison to State SBAC assessments. This evidence showed that students are improving on foundational skills as measured locally, but not on deep and transfer learning as measured by State assessments. Based on this, Goal 1, Action 1.8 provides teachers on special assignment (TOSA) who will provide targeted interventions to directly address both targeted small group Tier II & III academic foundational improvement as well as teacher coaching to improve in Tier I instructional practices that address academic language acquisition. These actions align with allowable uses of LREBG funds in the area of accelerating progress to close learning gaps through the implementation, expansion, or enhancement of evidence-based learning supports.

Reflections: Technical Assistance

As applicable, a summary of the work underway as part of technical assistance.

AUSD is eligible for Differentiated Assistance based upon the performance of English Learners and Long-Term English Learners in the areas of ELA & Math SBAC results and chronic absenteeism, and students with disabilities for their performance in ELA & Math SBAC results and suspensions.

With guidance from the San Luis Obispo County Office of Education, AUSD completed the Differentiated Assistance Needs Assessment. Through completion of the assessment it was identified that performance gaps stem from an overemphasis on surface-level knowledge in instruction and interventions, hindering deep understanding and transfer. A critical contributing factor is the underutilization of assessments that measure these higher-order skills, hindering our ability to tailor instruction and monitor progress effectively. This also perpetuates a cycle of prioritizing easily measured surface-level understanding. Our LCAP supports a robust MTSS that has successfully addressed foundational learning gaps in ELA and Math through targeted small group instruction and professional development, as indicated by local assessments. However, CAASPP data reveals a persistent struggle with deep and transfer knowledge/skills despite growth in foundational areas. Through

our MTSS system, we identify students for intervention through regular data reviews and monitor effectiveness monthly and continue to see improvements in our local assessments.

Moving forward, we will enhance intervention and assessment plans for 2025-26, focusing on targeted small group interventions and instructional coaches to strengthen Tier I instruction in language acquisition and deep learning. This aligns with the ongoing LCAP review process, which actively engages stakeholders. Progress will be measured using LCAP benchmarks and metrics, with CAASPP IABs/FIABs planned for future deep learning assessment. Our long-term strategy for success and scalability involves investing in professional development and coaching to embed language acquisition and deep learning within Tier I instruction, aiming to reduce reliance on Tier II & III interventions. In the areas of suspension and attendance, continued implementation of PBIS and Leader in Me will support student improvement. These both were in the implementation stages during the 2024-2025 school year and with continued implementation to get to institutionalization, systems will be in place to support positive climate and culture across campuses.

Actions 1.7 in Goal 1 will support student academic improvement.

Actions 2.2 & 2.4 in Goal 2 will support students in improving attendance and suspension rates.

Throughout the 2024-2025 school year, the Principal held School Site Council meetings to seek input on the student needs, possible solutions, and feedback on the district's implementation of our actions and services, and for the SPSA. Meetings included presentation of actions and services and solicitation of specific input to inform how to support students with extended and accelerated learning opportunities and meeting social/emotional needs of students and additional training needed for staff. Input was used to develop both the school's SPSA as well as how to best utilize the school's Equity Multiplier funds.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Influence on LCAP:

Throughout each meeting and survey, educational partners identified support for continuing our current LCAP actions and services. In reviewing student evidence and data, the common needs identified were in the areas of: utilization of more rigorous interim assessments, improving our systems for reporting attendance and discipline into Aeries and supporting students in these groups, expanding counseling services at the elementary schools to eliminate the sharing of staff, continuing small group targeted interventions in our Multi-Tiered System of Support across elementary schools and targeted interventions at the high school level, continuing counseling for behaviors and social/emotional needs and the implementation of PBIS and Leader in Me character education, and working to utilize supplemental funds in the general classroom for instructional support. Overall, input reinforced the need to continue current academic initiatives and school climate and culture efforts.

Outcomes specific to this input were:

- The addition of 1 counselor for elementary grades to eliminate the sharing of staff across our largest elementary schools
- Additional staffing for targeted intervention at elementary schools through the use of LREBG funds
- Addition of instructional coaches at the elementary and middle grades to support Language Acquisition through the use of LREBG funds

SELPA administrator reaffirmed the actions supporting students with disabilities during district consultation meetings.

Influence on Equity Multiplier Schools:

Carrisa Plains educational partners were clear that the priority continues to be maintaining additional staff to support targeted intervention through small group instruction. Additional staff will remain for the upcoming year.

An explanation of why the LEA has developed this goal.

Data shows achievement gaps for English learners (EL) and Students with Disabilities (SWD) student groups. EL scores declined on recent assessments, while overall scores showed modest improvement. The district's Special Education Plan addresses core subject achievement and college/career readiness for SWD students. While college readiness metrics are promising overall, there is a gap for minority students, including EL and homeless students. There is a similar gap in participation and completion of Advanced Placement (AP) and Career Technical Education (CTE) programs.

To address these gaps, the district will provide targeted local assessments supported by the full implementation of a multi-tiered system of supports (MTSS) with additional staff. This approach is aligned with research which shows that MTSS can be effective in improving achievement for all students, specifically those who are struggling [1]. The MTSS will provide targeted interventions and small group instruction, as well as 1:1 support through counseling, guidance, and accountability. The effectiveness of these actions will be monitored through a combination of local progress monitoring measures (e.g., local academic assessments, documentation of student contact for additional services) and state achievement indicators. Research suggests that local progress monitoring data can be a valuable tool for informing instruction and improving student outcomes [2].

Goal Analysis for 2024-2025

An analysis of how this goal was carried out in the previous year.

All Actions/Services in Goal 1 were implemented as intended with no substantive differences. Some minor differences were seen due to staffing shortages and resulted in hiring through contracted services to fill the supplemental positions to provide targeted support through our MTSS system. This continues to be a struggle throughout the State and not unique to AUSD. Success include continued growth in local assessments across subgroups, and improvements in CCI indicators.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

All funds that were budgeted for Actions/Services in Goal 1 were used to implement the intended Actions/Services with only minor material differences due to staff hirings.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

AUSD continues to place a heavy emphasis on utilizing our MTSS system to support any learning loss and needed growth of our students. Some key evidence of the effectiveness of actions 1.1, 1.3, & 1.4 include:

- Reclassification Rates and English Language Progress Indicators are both flat, though both EL and LTEL students are showing increases in their local FastBridge results for both ELA & Math. Decreases for these students in SBAC results have been found to be a limiter in reclassification for most EL students.
- Both ELA & Math FastBridge assessments show increases across all subgroups.
- Both ELA & Math SBAC show slight decline overall, and across subgroups.

During the 2024-2025 school year we saw an ongoing need for our EL, LTEL, & SWD subgroups, who continue to show the least progress in ELA & Math CAASPP results. We continue to see growth in each subgroup in our local assessments and EL English language development, which is evidence that our MTSS and class specific interventions continue to be successful. This contrast in results demonstrates that our students continue to grow in surface knowledge/skills as measured by FastBridge assessments, but struggle with deep and transfer knowledge/skills as measured by CAASPP assessments. The growth seen in EL students was directly supported by Action 1.6.

At the secondary level, an increase of 3.4% of students identified as Prepared according to College Career Indicators, bringing us to 41.7% of all graduates qualifying as prepared. Within the CCI indicators A-G and CTE Completion continue to be the highest area of need, with only 11.3% of CCI Prepared students meeting both qualifiers. It is difficult to directly attribute this success to Action 1.5 due to low incidents of data entry to Aeries. This is an area of improvement for the upcoming year.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

For the upcoming year, no changes are anticipated to be made to the metrics or targeted outcomes of Goal 1, though there will be one additional action for this goal, Action 1.7. Our continued focus for Goal 1 will be supporting our targeted subgroups and their Tier II needs through our Walk-to-Learn and support classes, supporting this through the use of LREBG funds and targeted interventions while we work to add to our Tier I support within the general classroom setting with instructional coaching that will also be provided through LREBG funds. At the secondary levels, systems for student access to counselors and counselor review of student progress towards CCI Preparedness will be reviewed and improved.

In reviewing reasons for counseling contacts, there is a large discrepancy when looking at low-income students in comparison to non-low-income students. Low-income students make up 48% of our school district, but we have a higher percentage of low-income students seeing their counselor because of attendance, behavior, and social/emotional, than their non-low-income peers (67% to 33%). We will continue the use of counselors at all levels to provide individual support, while building upon school-wide efforts in PBIS and character education. A study by OpenRiver [1] highlights the increased stress and emotional burdens faced by students from low-socioeconomic backgrounds, potentially contributing to this disparity.

District wide attendance and graduation rates continue to rebound post COVID, while suspensions remain high at the middle school level and with students with disabilities and low-income students making up the largest student groups in this category across the district. To support this, a more defined and utilized continuum of services for Tier I and Tier II Interventions, enhanced PBIS practices and character education are a high priority across the district. Efforts will be made to strengthen school-wide interventions including:

- Implement a Tiered Intervention Model (Tier I: Universal SEL for all students, Tier II: Targeted interventions for at-risk students) as research by Frontiers in Psychology [2] suggests it can be particularly effective for low-income students.
- Enhance Positive Behavioral Interventions and Supports (PBIS) practices to create a supportive school environment that reduces behavioral problems. CollegeXpress [3] highlights how SEL programs can contribute to this goal.
 - Emphasize Character Education to foster positive social-emotional skills.

Metrics will be improved to include both local and state data. Local data will be collected in the Fall and Spring with State data updated in the Winter, providing a combination of lead and lag measures, to best provide information to adjust practices as needed. Implementing a system that includes both local and state data (attendance, suspensions, alternatives to suspension, and parent engagement) will allow for ongoing monitoring and adjustments to practices as needed. This aligns with best practices in school improvement [4].

By prioritizing social-emotional support, implementing targeted interventions, and utilizing data effectively, the school district can address the specific needs of low-income students, improve school climate, and ultimately enhance academic outcomes for all students.

Goal Analysis for 2024-2025

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

All Actions/Services in Goal 2 were implemented as intended with no substantive differences and no significant challenges. This year marked a shift in provision of PD for Leader In Me and PBIS to being primarily provided by internal trainers. This implementation has been successful and will continue throughout this year and increased as we move into next year. Implementing both a PBIS systema and Character Education program simultaneously provided a small challenge, as the two can sometimes be seen as two separate programs rather than two supporting programs. As we transition from the implementation phase to a systemization phase, PD will focus on how these programs support each other.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

All funds that were budgeted for Actions/Services in Goal 2 were used to implement the intended Actions/Services with no material difference.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The 2023-2024 CA Dashboard showed an overall decrease in suspensions, with a slight increase for ELs and Homeless subgroups, although current suspension data shows us on track to have an increase in suspensions over the Dashboard results. This is the first year for monitoring the percentage of students receiving alternatives to suspension and post suspension counseling services. Current data shows that 251 students violated Ed Code 48900, with only 179 of them being suspended (representing a 0.45% increase from the previous year). In reviewing the students who violated Ed Code 48900, 31% of those students have received alternatives to suspension but not suspended, 8% received alternatives to suspension and were still suspended, and 61% were suspended with no alternative given. Of the students suspended, 8% of those students received post suspension counseling. Through our systems review and input gathering, we determined that the implementation of alternatives to suspension and post-suspension counseling was not well documented or commonly implemented across sites. Additional training and support will be put into place to support these actions and to provide better evidence of effectiveness. Actions 2.1 and 2.3 both contribute to the initial effectiveness of these results, and to increase the effectiveness, strategies utilized by counselors and the SRO will be shared across staff to support student support and data entry.

Actions 2.2 & 2.4 are both in their initial stages but are already showing effectiveness. While our current number of suspensions do not show a decrease in the number of students suspended, we recognize that most of our schools are in the implementation stage of PBIS and character education programs, and that as these are fully implemented and institutionalized, the impact on school climate and culture will be felt more, and suspensions will decrease. Two surveys are utilized to measure the implementation and effectiveness of PBIS and Leader in Me, the TFI and MRA respectively. As a district we have seen increases in both surveys, demonstrating strong implementation and continued improvement as seen by staff, students, and parents. These survey results have been echoed through the input from educational partners as multiple partners speak of the positive culture on campus across the district.

For the coming year, no changes are anticipated to be made to the metrics, desired outcomes, or actions of Goal 2. Action 2.1 will be expanded to include 1 additional counselor, to provide 1 counselor for each large elementary school within the district, removing the requirement to share staff, thus providing increased and improved services at each site.

An explanation of why the LEA has developed this goal.

Investing in the development and retention of high-quality teachers and staff is a well-established strategy for improving student achievement across all subjects, including literacy, math, and career and technical education (CTE). This includes providing ongoing professional development (PD) opportunities that are aligned with new curriculum changes and to address teachers' specific needs. Over the past 2 school years, the district has adopted new curriculum in all core academic areas, begun work on Visible Learning, and initiated efforts around PBIS. Newly adopted curriculums are updated to include instructional strategies, targeted support, and EL materials. The targeted professional development provided has supported teachers in content knowledge, instructional practices, writing, and the use of assessments. The effectiveness of professional development and the implementation of strategies will be measured through surveys, and then be seen in improved student outcomes in Goal 1 and implementation metrics in Goal 3.

Supporting Research:

- A study by the National Bureau of Economic Research found that students with effective teachers experience significantly higher academic achievement gains than those with less effective teachers [1]. This effect holds true across subjects and student demographics.
- The National Staff Development Council emphasizes the importance of PD that is job-embedded, focused on improving teacher practice, and connected to student learning goals [2].

Goal Analysis for 2024-2025

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

All Actions/Services in Goal 3 were implemented as intended, with no substantive differences or challenges. The rate of district-wide implementation of PBIS and character education was increased from a multi-year plan that had schools starting at different times over the next 4 years to one that has all schools starting the process in 2 years. This expedited implementation was a shift in efforts, but one that we have been able to adjust to and is being supported through our professional development efforts provided by AUSD presenters. This has been a success as stated in PD survey results. Challenges for providing PD continue to be scheduling and availability of substitute teachers. Efforts will continue to look for creative solutions to provide training during the contractual day.

The professional development provided through the Action 3.1 have resulted in positive responses from staff in their satisfaction and usefulness of the PD. Input from staff and administrators show a desire for more opportunities for learning and application of PD. On a scale of 1-5, the PD offered yielded the following averages:

- Leader In Me = 4.5
- PBIS = 4.5
- Curriculum = 3.9

Professional development and the support of teacher growth continues to yield positive responses from staff. As PBIS and character education programs are fully implemented, professional development will transition to be more targeted towards language acquisition and deep and transfer instructional strategies.

Priority 4: Pupil Achievement

An explanation of why the LEA has developed this goal.

Carrisa Plains School is extremely small, serving approximately 20 students across 5 grade levels. Students are separated into 2 classrooms where teachers and instructional aides work to support the multiple grade level curriculums and the broad academic needs of the students. Local data and state indicators show lower achievement for low-income students as well as all students across the board in comparison to other schools within the district. Parents, teachers, and staff representing the School Site Council reviewed this data with the principal and the educational partners suggested hiring an intervention teacher to provide targeted support for students who are academically behind.

To address these needs, the site will employ a part-time additional teacher to enhance their multi-tiered system of support (MTSS) by providing targeted small group and individual intervention. This approach is aligned with research which shows that MTSS can be effective in improving achievement for all students, specifically those who are struggling [1]. The MTSS will provide targeted interventions and small group instruction, as well as 1:1 support through counseling, guidance, and accountability. The effectiveness of these actions will be monitored through a combination of local progress monitoring measures (e.g., local academic assessments, documentation of student contact for additional services) and state achievement indicators. Research suggests that local progress monitoring data can be a valuable tool for informing instruction and improving student outcomes [2].

An explanation of why the LEA has developed this goal.

Paloma Creek High School, an alternative high school for grades 11-12, is in need of expanding its offerings to help students meet college and career readiness benchmarks. Parents on the School Site Council love the school's ability to meet the core requirements for graduation but asked about expanding offerings to include trades experience and college exploratory courses. They shared with the principal that these offerings would help their students be more prepared for life after school. School staff and District management agree that the current curriculum is limited in its focus on core academics (English, math, history, science), we agree there is a need to offer a more diverse range of opportunities to prepare students for both college and careers. Recognizing the unique needs of the student body, Paloma High School provides targeted English Learner (EL) support to ensure all students, including our large populations of low-income and white students, can thrive in their chosen paths

To address this gap, we're introducing:

- Online college courses: This allows students to explore diverse subjects beyond our core curriculum.
- CTE courses at neighboring high schools: This provides access to specialized career and technical education programs.
- CTE internship opportunities: Students can gain real-world experience relevant to their career goals.

We understand the unique needs of our English learner (EL) population. To ensure their success, we'll provide additional adult support for accessing these new opportunities.

The effectiveness of these initiatives will be tracked through the California State Dashboard College and Career Indicator (CCI). We anticipate that these expanded options will lead to an increase in the number of students meeting CCI requirements.

All Actions/Services in Goal 5 were implemented as intended, with no substantive differences, although the implementation process has not been what was expected. Students have been resistant to enrolling in online CTE courses to complete their pathways. We are currently in the process of exploring in person college coursework opportunities, CTE Dual Enrollment options or physical workbooks as an alternative to online classes.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

All funds that were budgeted for Actions/Services in Goal 5 were used to implement the intended Actions/Services with no major material differences, but limited expenses thus far. Because students were slow to enroll in online CTE classes, expenditures were directed towards building short term internship opportunities for and exposure to work-based learning in our community. This included field trips to local cosmetology schools as well as Cuesta College CTE Departments. Students increased their awareness of possible pathways post-graduation and partnerships have been strengthened between post-secondary institutions, local tradespeople and Paloma Creek High School.

Through the implementation of the actions/services in Goal 5, students are expanding their knowledge of internship opportunities and trades in the local community. They have been exposed to a wide variety of trade pathways. Connections have been forged between local businesses to establish work-based learning opportunities. These include local salons, construction trades and agriculture.

Counseling Support

Need:
Across the district, we have noticed through data analysis that our EL, & low-income students are over-identified relative to their grade level peers across multiple sites, in the suspension rate as noted in the metrics section. Counseling support has been voiced as one of the highest needs through all LCAP Steering Committee meetings, and input gathering from site and district administrators.

Scope:

LEA Wide

In response to strong educational partner feedback, we have invested in additional counseling across the district to specifically support our students. All elementary sites now have access to counselors to offer Tier I & II social-emotional support and provide small group and individual counseling. At the secondary level, similar strategies will be employed, supported by counseling interns who are under the direct supervision of the Behavioral Health Coordinator at Atascadero High School.

Counselors provide support for peer issues, drug and alcohol counseling, small group therapy meetings, and opportunities for family support to help students stay engaged at school. See Goal 2 Description for applicable research supporting counselor support.

Counselors will prioritize services towards supporting students in the area of individual student behaviors, peer relationships, and PBIS strategies to reduce suspensions. These services have proven to be successful for the intended student groups and we anticipate it will also be effective for all students. Actions will be principally directed to unduplicated students and will be extended to support all students with similar needs.

Action:

PBIS & Leader in Me: Character Development

Need:

Input from multiple educational partners stated that citizenship, behaviors, and school climate are a priority and expressed the need and urgency for all schools to have solid systems in place to teach these skills to students. Evidence on the California State Dashboard data support this feeling, showing that LI, FY, & EL have high percentages or large increases in metrics that are related to student engagement: suspensions, chronic absenteeism, and CCI.

Scope:

LEA Wide

The combined use of quality PBIS and character development programs has been shown to be effective in improving academic and behavioral outcomes for all students. Research from a cluster randomized trial suggests that integrating a high-quality Social-Emotional Learning (SEL) and character education program with Tier 1 PBIS can lead to significantly larger improvements in student behavior expectations, discipline, character development, and even academic engagement time compared to PBIS alone[1].

The Climate/Culture Coordinator will support all schools with their implementation of PBIS & Leader in Me to help improve School Climate and Safety. This is a crucial step. Effective implementation of both PBIS and character development programs requires ongoing support and professional development for educators. The Climate/Culture Coordinator can play a vital role in ensuring fidelity to the programs and fostering a positive school climate that supports student success [2].

School Resource Officer (SRO)
Need:
Across the district, we have noticed through data analysis that our EL, Foster, and lowincome students are over-identified relative to their grade level peers across multiple sites, in the suspension rate as noted in the metrics section. Student Ambassadors and site administrators both verbalized the support they feel from the SRO and the importance of maintaining this action for our secondary schools.

Scope:

LEA Wide

We have invested in a SRO to support attendance and implementation of our PBIS programs to specifically support unduplicated subgroups at the secondary level. We have contracted Atascadero Police Department to provide the SRO to ensure that our sites remain drug free and to lower the suspension, expulsion, and dropout rates of the identified groups. We anticipate that this action will lead to improvements in each group, similar as it will to our unduplicated students.

A study by McCurdy et al. (2019) highlights that the goals of School Resource Officers (SROs) can align with Positive Behavioral Interventions and Supports (PBIS) frameworks. The study highlights the benefits of behavioral support with a focus on positive reinforcement and social-emotional support through their law enforcement presence.

Fostering a deeper understanding of language acquisition: The focus on ELD curriculum, instruction, and assessment will equip teachers with the knowledge and skills to support EL and LTEL students' language development effectively.

Providing targeted support: The emphasis on early reading, mathematics interventions, and proficiency scales will enable teachers to identify and address the specific needs of struggling LI, EL, and LTEL students.

Building a supportive school climate: PBIS and Leader in Me components will contribute to creating a positive and inclusive learning environment essential for LI, EL, and LTEL students' success.

Professional Development Surveys will support the effectiveness of the training and identify additional needs of staff

While the Professional Development will be targeted to support El and LTEL, the instructional strategies and professional development for these targeted groups are very often also the best practices for students experiencing similar academic deficiencies. We know that by expanding these trainings to all teachers and implementing Professional Development LEA wide, we will impact all students positively.

o This amount is the total of the Estimated Actual Percentage of Improved Services column.

• Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)

 This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).
